Small Estate Indemnity

This form replaces our requirement for Australian Probate or reseal of Foreign Probate, where permitted under Australian law, when the current market value of the securityholding does not exceed AUD\$25,000. If the deceased did not leave a valid Will an *'Intestacy Request and Indemnity'* form must be completed instead.

Step 1: Details of the securityholding

- The Holder Reference Number.
- The full name of the registered Securityholder. Provide your estimate of the market value of the securities
- The address details as they appear on the register.

Step 2: Details of the executor(s) or administrators(s)

Provide the full name of the executor(s)/administrator(s).

Step 3: Signing instructions

All executor(s)/administrator(s) must sign in the spaces provided. Write the name of a contact person and telephone number. These details will only be used if we have a query regarding this form. DO NOT forget to date the form.

Step 4: Returning your form

The original *'Small Estate Indemnity'* form must be returned to Computershare. We cannot accept a copy, fax or email, so return it by post to the address above.

How to certify a document

- 1. The document must be certified by someone who has permission to do so under State law such as Justice of the Peace, Chartered Accountant, etc.
- 2. The certifying officer's name, position and contact number must be clearly stated on the document.
- 3. All pages of the document must be certified.
- 4. The certification must contain a statement to the effect that it is a 'true and correct copy' of the original.
- 5. The stamp and/or statement and signature of the authorised person must be original. No photocopies or faxes of the certification are acceptable.
